

International Parkour Federation Affiliation Criteria

National Federations (NFs) wishing to become affiliated to the International Parkour Federation (IPF), the world governing body for parkour, freerunning and related disciplines, need to meet the following requirements. These are based on the IPF Statutes and By-Laws.

Letter of Application

Apply to the IPF in writing declaring that the constitution of IPF will be strictly observed. This letter shall include:

- 1. Name of the NF
- 2. List of elected officials
- 3. Mailing address
- 4. Contact name
- 5. Contact phone number
- 6. Contact email

Constitution

The NF constitutions / statutes / by-laws must include clauses that:

a) refer all unresolved disputes between the NF and IPF to the Court of Arbitration for Sport (CAS);

and b) the NF has Anti-Doping Rules that comply with the WADA Code and IPF Anti-Doping Rules.

The IPF will assist NFs with compliance and governance structure.

Governing Body Status

The NF must be recognized or be seeking recognition as the sole governing body for the sport in your country. Either the applicable National Olympic Committee (NOC) or National Sports Agency (NSA) must confirm this status. NFs without current recognition may request a letter of support from the IPF when applying to their NOC or NGSA. In the event the NFs NOC or NSA requires membership of a recognized IF to achieve recognition in their country, the IPF

will write a letter stating it is the sole international federation seeking recognition for parkour and related disciplines and is applying for observer status with the Global Association of International Sporting Federation (GAISF.)

Affiliation Fee

No annual fee is required at this time, however fees will be introduced once the IPF achieves official recognition as an international sport.

Annual Report

An annual report must be submitted by 31 March each year, and shall include:

- 1. Address, telephone and email of the NF
- 2. List of elected officers, i.e., Executive Board
- 3.An indication that 10% of the Executive Board is represented by women. Please provide their names and positions.
- 4. Dates and Results of major Championships and events held during the previous year, i.e., National and state or provincial championships

Once approved:

- Elite, junior, U/23, age group and para-athletes who will compete at IPF World Championships, World Series, Continental Championships or Continental Cup events must be registered by the NF on the IPF website "international park our federation.com".
- Each athlete entered by the NF will have a "profile page" which can be self-managed by either the NF or the athlete.
- NFs should post weekly or bi-weekly news stories on their webpage on "internationalparkourfederation.com".
- NF homepages will display the IPF logo linking to international parkourfederation.com.

National Federation Starter Kit

IPF has a "starter kit" available for NFs that includes important resources to support new federations. The Starter Kit includes information on coaches'
